**Re: Superior Recreation User Group (RUG)  
Comments on Apache Leap Special Management Area**

Dear Mr. Bosworth,

In response to the Tonto National Forest's request for input from the public regarding the Apache Leap Special Management Area (ALSMA) Plan, the Superior Recreation User Group (RUG), a subcommittee of the Superior Community Working Group, would like to submit several requests for your consideration in developing the plan. These comments relate primarily to section (g)(5)(B)(ii) of Section 3003 of H.R. 3979 requiring the Secretary to consider measures to provide access for recreation.

The Recreation User Group's comments are mainly concerned with future recreation opportunities. The group is in the process of developing a comprehensive, multi-stakeholder, multi-use trails and recreation plan that includes the ALSMA area for Forest Service analysis in future Environmental Assessments. Key assumptions of this plan (to date) include the following features and access requirements, which the group requests be included in the ALSMA:

- The development of a hiking trail at the base of Apache Leap. This area has historically been used for informal hiking for many years by area residents and visitors.
- Multi-use trails (including mountain biking use) in topographically feasible areas within the ALSMA
- Continued access to the Cross Canyon Road, FR 2440

The RUG requests that the ALSMA preserves the ability to use the area for the recreational purposes listed above, pending separate NEPA analysis. We believe that continued historic uses and the expanded recreational venue will provide educational opportunities for future visitors to learn about Apache Leap and its rich cultural background and the connections with Native American history.

Additionally, the group would like to emphasize their recommendation that ongoing consultation with all affected communities and stakeholders, both on a government-to-government and informal basis, be implemented by Tonto National Forest.
